

EXPERT TERMS & CONDITIONS

These Expert Terms & Conditions are made between you and MEAPOINT LLC-FZ, a company registered in the Meydan Free Zone, Dubai, United Arab Emirates, with its office at Meydan Grandstand, 6th floor, Meydan Road, Nad Al Sheba, Dubai, United Arab Emirates ("MEAPOINT").

Overview

By joining the MEAPOINT Expert Network, you acknowledge and agree to the following:

- You are not bound by any duty or obligation to a current or past employer, or any other person or entity, that would prohibit you from consulting
- You should not cause any conflict of interest
- You should not be revealing any confidential information (non-public information) that could lead to insider trading
- You will not go around our system to engage with a Client that we introduce to you (see Non-Circumvention below)
- You will comply with any other pre-existing rules, regulations and agreements to which you are subject

Intellectual Property

Advice and content shared during a Consultation with a Client are solely owned by the latter.

Content you create independently of, or prior to, any project ("Retained Content") remains your property and you retain all rights, title, and interest in and to such Retained Content; however, you grant the Client a perpetual, world-wide, royalty-free, and transferable license to use any Retained Content included in your work with the Client.

Any inventions, discoveries or improvements that are based in full or in part on any content and information you create for a Client in the course of a Consultation shall be owned entirely by the Client.

Payment Timing and Tax Requirements

Within 30 days of completion of a Consultation, MEAPOINT will pay you based on your individual hourly rate. All rates and payments are in US dollars (USD).

You agree that you are responsible for paying any applicable taxes in your jurisdiction.

If the Client challenges your level of expertise and the Client ends the Consultation feeling his/her questions are unanswered, you shall not be paid for your participation.

Reliance by Clients and You

These Terms & Conditions are intended to benefit yourself and Clients. Clients expect that all projects will be carried out in accordance with these Terms & Conditions and applicable laws and that, among other things, they will not receive any confidential information.

Independent Contractor Status & Termination

It is understood and agreed that any services performed by yourself under these Terms & Conditions shall be performed as an independent contractor and consultant, and you further understand and acknowledge that this agreement shall come into force on the date of your acceptance of it and shall continue until terminated by either yourself or MEAPOINT.

Non-Circumvention

For 24 months after your last Consultation with a Client that MEAPOINT introduced to you, you will not, directly or through any other person, solicit, negotiate with or be engaged by that Client for services similar to those arranged through MEAPOINT, without MEAPOINT's prior written consent. Any such request from a Client should be passed to MEAPOINT.

Non-Liability

MEAPOINT shall not be liable to you for any damages or legal costs relating to your participation as an Expert member.

MEAPOINT agrees that for its part it shall not seek to impose on you any liability for damages or legal costs.

Jurisdiction

Any dispute, controversy or claim, whether in tort, contract or otherwise, arising out of or in connection with these Terms & Conditions shall be subject to the exclusive jurisdiction of the courts of Dubai, United Arab Emirates.

Each party is responsible for its own legal fees and expenses. You agree to bring any claim on an individual basis.

Governing Law

These Terms & Conditions, as well as any claims arising from or related thereto, whether in tort, contract or otherwise, are governed by the laws of the United Arab Emirates as applied in the Emirate of Dubai.
